
Claiborne County Sheriff's Office Monthly Report

OFFICE OF THE COUNTY MAYOR

As you know, our county has been hit with the COVID-19 pandemic. With the issuance of Governor Lee's executive orders there has been a declared state of emergency for Tennessee, a stay at home order and the closure of businesses. These actions have had an impact on all ninety-five of Tennessee's counties and has temporarily changed the way we are doing business. To that end, most of the May 2020 report will be a recap of the reaction to the ongoing COVID-19 pandemic here on the county level.

Continued attendance of White House COVID-19 Briefing via a conference call to hear the direction Washington DC is taking to combat the ongoing pandemic.

Participated in weekly county mayor's conference calls to discuss and share ideas with that each county is doing to react to and prepare for a future with COVID-19 in it.

Continued to coordinate with Tennessee Department of Health (TDH) and local Health Department to provide daily COVID-19 test numbers, new guidelines, and recommendations.

Meet with George Coats to discuss ongoing water/gas projects going on in the county.

Attended a statewide WebEx call with Governor Lee to discuss the COVID-19 vaccine distribution.

Meet with local business owner to discuss infrastructure needs needed at their location.

Attended ETHRA and ETDD Audit Committee meeting via Zoom to approve the audit findings for the agencies and to give recommendations to the full boards.

Attended ETHRA Policy Council and ETDD Executive Committee meeting via Zoom.

Lobbied on behalf of the ARC/SUD INSPIRE Grant application on state and federal level.

Attended a statewide Mayor's call via Zoom hosted by Governor Lee to hear from the Tennessee Department of Health Director Dr. Lisa Piercy to give updates on the vaccinations moving forward as well as other COVID-19 health related information.

Attended the LGA/AGA Cyber Aware Webinar hosted by the state via WebEx to discuss cyber security awareness.

Attended NOW Executive meeting to discuss the further development of the RCORP-NAS Logic Model and to continue developing the needs assessment survey.

Attended the MVEOA quarterly board meeting via Zoom.

Attended a Zoom call to discuss the possibility of added curriculum to the TCAT course offerings related to meat packing.

Attended a Zoom meeting for Pretrial Networking to learn of the impact COVID-19 is having on our court system.
