#### ITEM #4 - DISCUSSION - Opioid Lawsuit

Commissioner Honeycutt introduced District Attorney General Jared Effler for this discussion item. General Effler spoke with commission with an update on the pending opioid lawsuit. He stated that the case has been through appeals that have been heard and appeals that have reached the Tennessee Supreme Court and that that court has recently ruled that the Drug Dealer Liability Act does apply to Big Pharma and they can be held liable. Secondly, the Supreme Court considered whether or not District Attorney Generals could sue Big Pharma as plaintiffs. The Supreme Court found it was a technical error and that, in order to proceed, the District Attorney Generals could not be plaintiffs and that Claiborne County would need to retain General Jared Effler and the law firm which has been representing the District Attorney Generals since 2017. Also present was Tricia Hertzfield from the law firm of Branstetter, Stranch and Jennings. She relayed to the commission that a considerable amount of work has already gone into this lawsuit process such as depositions, countless documentation reviews and travel.

County Attorney Estep advised commission to approve a resolution to retain District Attorney General Jared Effler and the Branstetter, Stranch and Jennings law firm as counsel to proceed in this lawsuit on behalf of the county.

WHEREAS, District Attorney Jared Effler is duly elected District Attorney General for the 8<sup>th</sup> Judicial District of the State of Tennessee.

WHEERAS, General Effler brought a lawsuit in 2017 through the law firm of

WHEERAS, General Effler brought a lawsuit in 2017 through the law firm of Branstetter, Stranch & Jennings, PLLC to recover money for Claiborne County under Tennessee's Drug Dealer Liability Act ("DDLA"), and that lawsuit is pending in Campbell County Circuit Court;

The Claiborne County Commission hereby RESOLVES that it fully supports the lawsuit, approves of the actions taken in the lawsuit thus far on its behalf, approves of the lawsuit going forward with Claiborne County as the named plaintiff, and retains District Attorney Jared Effler and the law firm Branstetter, Stranch & Jennings, PLLC as counsel in

WHEREAS, the Family First Coronavirus Response Act (HR 6201) was signed into law on March 18, 2020 which declared a COVID-19 period from March 1, 2020 through December 31, 2020 that provided fourteen (14) COVID-19 sick days to fulltime employees in addition to the regular sick time policy, and

WHEREAS, the provisions of the FFCRA have ended but the COVID-19 pandemic is still active, and

WHEREAS, the Office Holders, County Mayor and County Commission want to extend the same opportunity of 14-COVID-19 sick days to every fulltime employee who has not yet been impacted by COVID-19, and

WHEREAS, the original resolution establishing the Policies and Guidelines Related To The COVID-19 Pandemic expired on December 31, 2020.

**NOW THEREFORE BE IT RESOLVED**, the Policies and Guidelines Related To The COVID-19 Pandemic previously adopted in Resolution 2020-044 are to be extended retroactively to begin January 1, 2021 through June 30, 2021.

**BE IT FURTHER RESOLVED,** the Administrative Leave Policy To Cover The COVID-19 Pandemic Response in Claiborne County's Policies and Procedures previously adopted in Resolution 2020-045 are to be extended retroactively to begin January 1, 2021 through June 30, 2021.

**BE IT FURTHER RESOLVED,** the Sick Leave Policy To Cover The COVID-19 Pandemic Response In Claiborne County's Policies and Procedures previously adopted in Resolution 2020-046 are to be extended retroactively to begin January 1, 2021 through June 30, 2021.

**BE IT FURTHER RESOLVED,** the Sick Leave Policy To Cover The COVID-19 Pandemic Response In Claiborne County's Policies and Procedures previously adopted in Resolution 2020-046 are to be amended as follows:

- COVID-19 sick time shall be used for and only used for COVID-19 related leave, when an
  employee is unable to work because the employee is quarantined (pursuant to federal, state or
  local government orders or advice of a health care provider) due to a positive test result or
  contact tracing due to a positive test result from immediate family members (spouse, children,
  parents, etc.) living in their home.
- COVID-19 sick time during this extended period is only available to employees who have not already used them prior to the original period ending on December 31, 2020.
- Any employee who refuses to accept the COVID-19 vaccine when it is offered to them when
  they are eligible to receive it in their respective COVID-19 Vaccine Phase is not eligible to receive
  COVID-19 sick time thereafter.

## ITEM #5C - DISCUSSION - COURTHOUSE ROOF LEAKS

County Mayor Brooks addressed the commission with the continuing roof leak problems at the courthouse that occur with heavy rains. He informed that he has had no success in getting the roofers that had worked on the roof before to return. Mayor Brooks stated that the Building, Grounds and Personnel Committee had met prior to this meeting and recommended that the mayor reach out to 3 roofing companies to examine the roof, provide a resolution and pricing. He stated he would make the contacts and bring the findings to the commission.

#### ITEM #5D - DISCUSSION - COVID-19 UPDATE

County Mayor Brooks addressed the commission with updates on the COVID-19 statistics in the county. As of today, there are 321 active cases in the county and there have been 33 COVID-19 deaths. The county is currently on the 1a1 and 1a2 vaccination schedule but is experiencing limited vaccines. In the last 30 days the hospital has seen an 85-90% capacity with approximately one-half as COVID-19 patients. Mayor Brooks stated that hopefully the 1b vaccination schedule, which will include the K-12 students, will be in February/March. He expressed that persistence of mask use, social distancing and good hygiene practices will continue to help combat this virus.

## ITEM #5E - DISCUSSION - PURCHASING AGENT FOR THE COUNTY

County Mayor Brooks addressed the commission concerning a decision made by the finance committee concerning a purchasing agent for the county. Since the departure of the former purchasing agent for another job, the finance committee had resolved that hiring another full-time purchasing agent was not warranted and that the bid threshold would remain at \$10,000.00, which can be managed by the Finance Director. County Attorney Estep advised the commission to adopt the recommendation of the finance committee.
