#### ITEM #1 - DISCUSSION - "MAYOR FOR A DAY"

County Mayor Brooks introduced Miss Ava Cole, who was the winner of the art contest/fund raiser of the Claiborne County Animal Shelter. Miss Cole raised \$10,200.00 and as a part of being the contest winner, she was "Mayor for a Day". Miss Cole gave a presentation to the commission concerning statistics of the animal shelter and the expenses that the shelter incurs yearly. Miss Cole also discussed the need for an animal control officer for the county, equipment and communication needs and requested that the budget committee consider funding for a control officer. Miss Cole was presented a plague by County Mayor Brooks for filling in the role of "Mayor for a Day".

#### ITEM #2 - DISCUSSION - CHILD ABUSE PREVENTION MONTH

County Mayor Brooks informed the commission that April is child abuse prevention month and presented some statistical information of child abuse in the county. Mayor Brooks stated that child abuse cases are handled by the Family Justice Center along with the Dept. of Children's Services and the Child Advocacy Center. Mayor Brooks expressed appreciation to these agencies, along with law enforcement, the District Attorney General's office and the court system for their roles in the management of these cases.

Commissioner Peters introduced Bill Linn with information on the old church in Cumberland Gap. Mr. Linn informed the commission that he, and his wife Tammy, had purchased the old church and have been in the process of renovating it and the parsonage for an events and community center.
