SUBJECT: Significant Actions Report—May 2022

- 1. In May 2022, I worked 13 of 13 days. Lee worked half days. We had 36 veterans (or family members) in the office, and we responded to 18 veteran requests by the phone.
- 2. On May 11 we had monthly training on the computer through a Zoom meeting. It involved training dealing with the suicide rates and causes of veteran suicide. The national hotline for veterans who feel like they want to harm themselves is 1-800-273-8255. This has become a national crisis as about 22 veterans take their own life each day.
- 3. I had my first opportunity to file a claim for a veteran for TDIU. This is used only when it is apparent the veteran is not able to gain and sustain gainful employment. Under this program a veteran is paid at the 100% disability rate even when they are 60-70% disabled. There are many stipulations to this program and strict guidelines to qualify. We were told in Nashville during training in January to use this claim only when it's evident the veteran cannot work and no chance of their health improving.
- 4. I also did my first claim for a veteran who is still active in The National Guard but will be retiring in September 2022. It is obvious that his health has suffered through his 4 years active duty and his 30 years of service with the National Guard.
- 5. I was notified on May 20 that I was being considered for access to the national program of eQIP. This program helps a VSO (Veterans Service Officers) to view the status of a veterans claim and also shows the VSO what the veteran is drawing with compensation, in the case of lost paperwork (which is frequent).
- 6. On May 28 at 11A.M. I participated in a Memorial Day service held at the Tazewell Veterans Park across from the post office. It was a very solemn and patriotic event with The Pledge To The American Flag and the National Anthem. The Campbell County Honor Guard did the 21 gun salute and played Taps in remembrance to those veterans from Claiborne County (over 130 names on the wall) who has given the ultimate sacrifice for their country.
- 7. I want to thank Mr. Lee Brame (Retired Major) for his training and knowledge he has conveyed to me. He has helped me immensely in me getting my feet on the ground at this position of Veterans Service Officer. He is well respected in The Tennessee Department of Veterans Service. It would have been very difficult to navigate with the VA without his expertise.
