SUBJECT: Significant Actions Report—May 2024

In May 2024, I worked 14 of 14 scheduled days. I had 44 veterans (and/or family members) in the office. Twenty-two of these veterans had claims that I submitted and was approved or helped them to get a service connection increase in their disability. I also offered the veterans information on the additional benefits that may be available to them as their disability increased with age or disease. Many times, their healthcare and pharmacy benefits are also increased. There are eight levels of VA Healthcare for veterans. This involves different Co-payments and costs for medications. When a veteran becomes 50% disabled, they go in a different priority group and his or her medications that are prescribed by the VA primary care doctor become free of charge. Some veterans are surprised to learn of this benefit.

I responded and helped with another 23 veteran telephone call requests and/or email correspondence. Veterans' issues are varied and require knowledge in navigating the system to receive each service. It can be very confusing as there are different sections of the VA to navigate.

The Supreme Court has sided with a veteran in a VA Education Benefits case. The court has agreed that veterans can use benefits accrued under both the Montgomery GI Bill and the Post 911 GI Bill up to a 48-month benefit cap. Before the court decision the veteran was limited to 36 months of education benefits even though they were eligible for the Montgomery and the 911 Bills periods of service. This is estimated to affect about 1.7 million veterans.

Vetra-Spec is the program that the Tennessee Department of Veterans Service chooses to use in filing claims with the state. It has a new look, and it can do more now than when it was originally put in use. I am still dealing with these changes and hope that it can be the benefit they claim it will.

On May 8 training was offered regarding using the Board of Veterans Appeals as a way of resolving issues the veteran does not agree with. It seems that the wait time is still very lengthy even though the VA is attempting to streamline the process. The more complex the case the more expertise is needed to present the veteran's view of the case. To a degree video conferencing and cell phones have aided this process.
