ITEM #1A - DISCUSSION - BUILDING PERMIT FEES

Commissioner Shuford discussed the increase in building permit fees adopted by the commission last year. He stated that part of the discussion that took place at that time was that a building inspector could be hired using the added revenue which has not occurred. He further stated that some that have paid these fees are upset as the fees have come back down and is of the opinion that the commission should consider reimbursements. Mayor Brooks stated he did not veto the resolution so it stood to see how much money the additional fees would generate. He further stated that the commission did not hire a building inspector and he has received feedback that builders and others are upset for having to pay an unfounded tax and he treated that as a discretionary item to take the fees back to where they were prior.

Following further discussion, Mayor Brooks informed the commission that he will resume collecting the building permit fees as outlined in the resolution passed in 2023.

ITEM #1B - DISCUSSION BY RESIDENTS CONCERNING A ROAD IN DISTRICT 2

Residents from District 2 spoke with the commission concerning Freedom Road and requested assistance with getting repairs done to the road and with problems of people parking on the side of the highway hindering the view of residents to pull onto Highway 25E. She stated that 25 families live on the road and it is in dire need of repairs. Road Supt. Pittman informed the residents that it takes time to get to all the roads and that the roads are worked in line and based on volume of use, traffic flow, schools, hospitals, churches, etc.

ITEM #1C - ANNOUNCEMENT BY DAN SPURLOCK, REPRESENTATIVE WITH SIGCO

Dan Spurlock, with Stand in the Gap Coalition, presented a newsletter and spoke with commission about upcoming events. He brought attention to the fact that September is National Suicide Prevention Month stating that a suicide occurs every eleven minutes in the Unites States and that over 50% of suicides have association with drug addiction, alcohol addiction and addiction processes. He further stated that the coalition is available to help anyone that has a need. Mr. Spurlock stated that the coalition is also working on a youth program to build a base with young people who can help other youth.
