SUBJECT: Significant Actions Report September 2025

In September 2025, I worked 14 of 14 scheduled days. I had 56 veterans (and/or family members) in the office. Many of these veterans had claims that had been submitted and were approved. Some of these veterans were assisted in getting a Service Connection increase in their disability. I also offered the veterans other information on the additional benefits that may have become available to them because of their age or other benefits that may be available to them as their Service-Connected disability was increased.

Many times, the veterans' healthcare and pharmacy benefits are changed, and they are put in a higher priority group as their disability changes, or their disability percentage condition is increased. Sometimes as their declining health conditions worsen with age there are other benefits that may become available. Some veterans were in the office to file a completely new claim for disabilities. Some veterans made applications for VA healthcare. I had several veterans report that their claim had been approved or they had received an increase in their benefits. This makes my job very rewarding.

I helped with another 37-veteran request with telephone calls or emails, including fax correspondence with information/planning etc. This office served a total of 45 veterans (and families) with service-connected disabilities ranging from 10%- 100% along with healthcare and pension claims. Issues with these veterans are varied and sometimes complex as the VA changes in their policies.

A program called "Community Care" within the VA Healthcare System is now changing for the betterment of the veteran. Under the old plan a veteran had to get authorization every six months to be seen outside the VA Medical Center or clinics. With the new law thirty specialties such as Cardiologists, Dermatologist and Pulmonologists can now be approved for up to one full year without recertification. This eliminates a lot of anxiety and worry for the veteran.

In September I completed my annual recertification with the HIPPA and Rules of Privacy both in the medical section for healthcare and the computer and other devices used to handle and send such private information.
