SUBJECT: Significant Actions Report October 2025

In October 2025, I worked 14 of 14 scheduled days. I had 53 veterans (and/or family members) in the office. Many of these veterans had claims that had been submitted and were approved. Some of these veterans were assisted in getting a Service Connection increase in their disability. I also offered the veterans other information on the additional benefits that may have become available to them because of their age or other benefits that may be available to them as their Service-Connected disability percentage was increased.

Many times, the veterans' healthcare and pharmacy benefits are changed, and they are put in a higher priority group as their disability changes, or their disability percentage condition is increased. Sometimes as their declining health conditions worsen with age there are other benefits that may become available. Some veterans were in the office to file a completely new claim for disabilities. Some veterans made applications for VA healthcare. I had several veterans report that their claim had been approved or they had received an increase in their benefits. This is the most rewarding part of my position.

I helped with another 35-veteran request with telephone calls or emails, including fax correspondence with information/planning etc. This office served a total of 44 veterans (and families) with service-connected disabilities ranging from 10%- 100% along with healthcare, DIC and pension claims. Issues with these veterans are varied and sometimes complex as the VA changes their policies or procedures.

I attended the required annual accreditation 3-day training in Knoxville TN September 29 to October 1. Various classes included but not limited to Anti-discrimination and The Retaliation Act along with other up to date procedures of the Veterans Administration. The TN Department of Veterans Service also announced that the goal for the Knoxville VA Healthcare System will be under one roof to include all medical specialties (plus optometry, dentistry, hearing, x-rays and scans) by the year 2030. They are in the process of looking for the location for this Knox County campus.
