December 26th, 2025 – Christmas Holiday




SUBJECT: Significant Actions Report December 2025

In December 2025, I worked 12 of 12 scheduled days. I had 44 veterans (and/or family members) in the office. Many of these veterans had claims that had been submitted and were approved. Some of these veterans were assisted in getting a Service Connection increase in their disability. I also offered the veterans other information on the additional benefits that may have become available to them because of their age or other benefits that may be available to them as their Service-Connected disability percentage was increased.

Many times, the veterans' healthcare and pharmacy benefits are changed, and they are put in a higher priority group as their disability changes, or their disability percentage condition is increased. Sometimes as their declining health conditions worsen with age there are other benefits that may become available. Some veterans were in the office to file a completely new claim for disabilities. Some veterans made applications for VA healthcare. I had several veterans report that their claim had been approved or they had received an increase in their benefits. This is the most rewarding part of my position. I had several veterans call or come in to tell me that they were approved up to 100% service-connected pay increase.

I helped with another 31-veteran request with telephone calls or emails, including fax correspondence with information/planning etc. This office served a total of 40 veterans (and families) with service-connected disabilities ranging from 10%- 100% along with healthcare, DIC and pension claims. Issues with these veterans are varied and sometimes complex as the VA changes their policies or procedures.

In December the Secretary for Veterans Affairs Doug Collins (1) Announced that the eight-month backlog for Champ-VA Health Program for dependents who are 100% disability had been cleaned up and now completing applications in 2-3 weeks. (2) Veterans also receive a 2.8% raise in their disability pay in 2026. (3) All Veterans Medical Centers across the nation now have a 4/5 Star ratings issued by Medicare and Medicaid.
