Sponsored a team for the 1st annual Heritage Christian Academy Sporting Clays fund raiser.

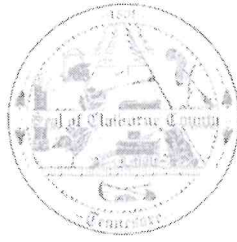
